#### **Clarifications:**

1. Page 7:
  - Non- Discriminating: Please delete the following paragraph from this section:
    - Firm shall comply with Section 285.525 – 285.550 RSMo regarding enrollment in a federal work authorization program. A signed, notarized affidavit (attached) and supporting documentation affirming enrollment in a federal work authorization program must be submitted with proposal. Failure to comply with this provision may result in rejection of proposal.
2. Page 7:
  - E-Verify: Please delete the entire paragraph titled “E-Verify”.
    - This project is below the \$5,000 per year requirement as set forth by the U.S. Department of Homeland Security and therefore does not apply.
3. Page 10 - 11:
  - Insurance Requirements:
    - The City of O'Fallon is amending the insurance coverage requirements from 3 million and reducing it to 2 million for this project. All other information remains the same.
4. Page 17:
  - Worker Eligibility Verification Affidavit: Please delete this page in its entirety. The affidavit is not required to be submitted for this project.
