ADDENDUM #1

The purpose of this addendum is to answer all questions received on or before 03/21/19 at 12:00 P.M. (central time). The time period for questions is closed.

Questions:

1. The bid for private request, is it only for the inside the city limits or is the pricing for where ever the customer wants to go?

Answer: It is up to the tow company to bid mileage, or not, inside the city. It is also up to the tow

company to bid any mileage price outside the city. Please specify on the pricing sheet

if the cost per mileage is for inside the city and/or outside the city.

2. If the customer's insurance is paying for the accident or tow is it still the private request price?

Answer: The request would be a private request. The Police would not differentiate on who is

paying for the accident or tow.

3. Or if the vehicle is getting charged to a repair facility (example a Body Shop or Firestone) from the scene of the accident or breakdown, is it still the private request price?

Answer: See answer #2.

4. If the vehicle gets transferred from the storage lot to a repair facility or any other destination is it still the private request price? (2nd Tow)

Answer: The second tow would be a business matter between the towing company and the

customer. The customer could hire a separate tow company for the second tow if they

wanted.

5. Is all the police tows pricing from scene of vehicle to storage lot? Example, stolen vehicle in St Louis taken to sally port, then to storage lot.

Answer: For this example, the police would consider this two police tows and any pricing by the

towing company should be reflected on the price sheet.

6. If the vehicle goes to sally port for evidence, then we come back later to tow it again. Is that considered two tows or one?

Answer: This is considered two tows.

7. Is the distance of the storage lot from the city considered in the bids? That could be a considerable price difference.

Answer: Yes. The pricing should be reflected in the towing companies price sheet in the per mile

and/or hourly rate.

8. If there is a tow sheet for an accident, example customer goes to the hospital and there is tow sheet written and the check box on the tow sheet is marked as accident, which price list is used?

Answer: This would be a private request/accident.
