## **CITY OF O'FALLON, MISSOURI** **PROPOSAL INSTRUCTIONS**

### **PURPOSE**

The purpose of this Request for Proposal (RFP) is to invite qualified, prospective vendors to submit a proposal to provide a Cloud-Based Disaster Recovery and Backup solution. The city is seeking a three-year agreement.

This RFP provides prospective companies with sufficient information to enable them to prepare and submit proposals for consideration by the City of O'Fallon (City) to satisfy the needs as outlined in the scope of work.

### **BACKGROUND:**

The city recognizes the importance of having a proper cyber security posture. Therefore, the city is looking to secure the current virtualized on-premises environment with cloud offsite backups and a reliable disaster recovery solution, capable of running all virtualized workloads in a redundant Cloud-Based Software Defined Data Center (SDDC) environment(s). This solution needs to provide all backup and disaster recovery capabilities with the ability to replicate & recover to any on-premises data centers (currently operated by the City), as well as to Cloud-based vendor managed SDDC in the event of a major catastrophic disaster. The solution ideally also needs to be fully vendor-managed with the ability to provide snapshot-based protection against ransomware, including an analysis which determines when the ransomware payload was first detected, so restoration occurs prior to this time. Vendor needs to provide complete disaster recovery services along with full reporting after each verified disaster recovery test (in accordance with the City's Cyber Insurance Compliance Policy). In addition, the vendor should assist the city in completing a Disaster Recovery Plan with all steps needed to deploy the SDDC for interim operations, and full restoration to on-premises equipment.

### **PROPOSAL SUBMISSION**

Sealed proposals must be received by the City of O'Fallon, Missouri; Purchasing Office, 100 North Main Street; O'Fallon, Missouri 63366 prior to February 19, 2026, at 12:00 P.M. (prevailing central time). Each proposal shall consist of one original (identified as such) and one electronic copy on flash/thumb drive of the complete proposal. The file submitted on flash/thumb drive must include all attachments and signatures, where applicable.

It is the responsibility of the proposer to ensure that their proposal is received in the Purchasing Office, prior to the deadline. Companies mailing proposals should allow ample mail delivery time to ensure timely receipt of their proposals. Proposals received after the deadline for receipt of proposals will not be opened or considered.

Proposals will be opened and evaluated in private by City staff. A public opening will not be held.

To make delivery of proposals for this project, the delivery vendor or bidder may hand deliver the proposal during City Hall hours of Monday – Friday 8:30 am – 4:30 pm. Mailed proposals are accepted with regular mail service each day.

Proposals must be clearly identified as a proposal for the City of O'Fallon, Missouri "**RFP # 26-009 Cloud-Based Backup and Disaster Recovery Solution**" and shall show such information on the outside of the proposal packet. Proposals will not be accepted by facsimile or email transmittal. *Do not staple or submit bid in any type of binder; binder clips are acceptable.*

### **TERMS AND CONDITIONS**

#### **QUALIFICATIONS:**

All companies shall be licensed, insured, and bonded and shall provide satisfactory evidence to the City that they have previously performed/provided the types of services as specified below.

#### **LAWS AND ORDINANCES, REGULATIONS, LICENSING FEES:**

Firm shall conform to all rules, regulations, ordinances, laws, or directives set forth by the City of O'Fallon and/or the State of Missouri.

#### **LAW GOVERNING:**

All State of Missouri and/or Federal Laws shall be hereby specifically made a part of this contract as set forth herein.

#### **NON-DISCRIMINATING:**

The Contractor, its employees and subcontractors, agree not to commit unlawful discrimination and agree to comply with applicable provisions of the U.S. Civil Rights Act and Section 504 of the Federal Rehabilitation Act, and rules applicable to each.

Firm shall comply with Section 285.525 – 285.550 RSMo regarding enrollment in a federal work authorization program. **A signed, notarized affidavit (attached) and supporting documentation affirming enrollment in a federal work authorization program must be submitted with proposal. Failure to comply with this provision may result in rejection of proposal.**

#### **E-VERIFY:**

Company shall be E-Verify compliant and shall provide documentation to support this requirement within the proposal including the memorandum of understanding (MOU) and the electronic signature page completed in its entirety.

#### **METHOD OF AWARD / SELECTION:**

The proposals will be evaluated by the City. A response summary of proposals will be available by contacting Julie Moellerling, Purchasing Agent. The response summary will only include the names of the companies that submitted proposals that were delivered by the required RFP submittal date and time. Until award of the contract, the Responses shall be held in confidence and will not be available for public review.

#### **TERMS/CANCELLATION AND DAMAGES:**

This contract may be terminated by either or both parties upon thirty (30) days' written notice or upon mutual agreement of both parties.

If the City, because of the Vendor's breach, terminates this Contract, the City shall have the right to purchase service elsewhere and to charge the Vendor with any additional cost incurred.

Notwithstanding the above, the Vendor shall not be relieved of any liability to the City for damages sustained by the City by virtue of any breach of this contract by the Vendor and the City may withhold any payments to the Vendor until such time as the amount of such damages due the City from the Vendor shall be determined.

## **AWARD REQUIREMENTS:**

Once the City is prepared to award the contract to the selected company, the company will need to provide the following documents to the City.

- Signed contract agreement
- Current certificate of insurance

Once all of these items are received and fully executed, then the City will issue the Notice to Proceed.

It is the desire of the City to award a single contract for the entire scope of services outlined in this request for proposals. All proposals are subject to staff analysis. The City of O'Fallon reserves the right to accept or reject any and all proposals received and waive any and all irregularities.

## **CONTACT WITH CITY OF O'FALLON PERSONNEL:**

As specified above, all contact with the City should be channeled through the Purchasing Agent. No contact with other City employees, officials, or City Council members is to be made by responding proposers throughout the entire process.

## **RESPONSE MATERIAL OWNERSHIP:**

All proposals become the property of the City of O'Fallon, Missouri upon receipt and will only be returned to the proposer at the City's option. Selection or rejection of the proposal will not affect this right. The City shall have the right to use all ideas or adaptations of the ideas contained in any proposal received in response to this RFP. Disqualification of a proposal does not eliminate this right.

## **PROPRIETARY INFORMATION:**

All material submitted in response to this RFP will become public record and will be subject to inspection after an Intent to Award notice is issued. Any material requested to be treated as proprietary or confidential must be clearly identified and easily separable from the rest of the proposal. Such request must include justification for the request and approval by the City Clerk. Neither cost or pricing information nor a total proposal will be considered proprietary.

## **CONFIDENTIALITY:**

The Vendor agrees that it will not permit the disclosure or duplication of any information received from the City or stored on City systems unless such disclosure or duplication is specifically authorized in writing by the City, or as required by law.

The City agrees that it will not disclose or duplicate any information designated in advance by the Vendor as "Confidential/Proprietary" information to any person (other than City personnel who must have access to such information) unless such duplication, use or disclosure is specifically authorized in writing by the Vendor or is required by law. The term "Confidential/Proprietary" does not include ideas, techniques, or concepts that are in the public domain.

## **EVALUATION RIGHTS:**

The City reserves the right to: a) reject any or all proposals, or to make no award, b) require modifications to initial proposals, c) make partial or multiple awards, or d) further negotiate costs submitted in proposals. The City reserves the right to award the contract in any manner deemed in the best interest of its citizens.

### **REJECTION OF PROPOSALS:**

The City of O'Fallon, Missouri reserves the right to reject any or all proposals received in response to this RFP, or to cancel this RFP if it is in the best interest of the City to do so. Failure to furnish all information or to follow the proposal format requested in this RFP may disqualify the proposal. Any exception to the Scope of Work must be identified in the proposal.

### **INCURRING COSTS:**

The City of O'Fallon, Missouri shall not be obligated or be liable for any cost incurred by proposers prior to issuance of a contract. All costs to prepare and submit a response to this solicitation shall be borne by the proposer.

### **SUBMISSION OF PROPOSALS AND SUPPLEMENTAL MATERIALS:**

Proposals shall be submitted to the Purchasing Office. If supplemental materials are required or requested, then they must be submitted to the Purchasing Office as part of the proposal. Supplemental materials will not be accepted after the proposals have been opened, unless requested by the Purchasing Office. Submission or distribution by the company of unsolicited supplemental materials to City employees or Officials may result in rejection of the proposal.

### **DISCRIMINATION POLICY:**

The City of O'Fallon advises the public that it does not discriminate against any person on account of race, color, religion, creed, sex, age, ancestry, or national origin, and that such nondiscrimination is extended to procurement of materials and/or the provision of municipal services.

### **WAIVER:**

The City reserves the right to waive any variances from the original RFP in cases where the variances are considered to be in the best interest of the City.

### **INSURANCE:**

The firm or company that is awarded a contract shall maintain during the life of the agreement and furnish to the City the appropriate Professional Liability, Commercial General Liability, and Workers Compensation insurance certificates listing the City of O'Fallon as an "Additional Insured" during the Term of the Agreement, and a copy of such "Additional Insured" endorsement must accompany the certificate.

### **INDEMNITY:**

The Vendor shall, at all times, fully indemnify, hold harmless, and defend the City and its officers, members, agents, and employees from and against any and all claims and demands, actions, causes of action, and cost and fees of any character whatsoever made by anyone whomsoever on

account of or in any way growing out of the performance of this contract by the Vendor and its employees, or because of any act or omission, neglect or misconduct of the Vendor, its employees and agents or its subcontractors including, but not limited to, any claims that may be made by the employees themselves for injuries to their person or property or otherwise.

Such indemnity shall not be limited by reason of the enumeration of any insurance coverage herein provided.

Nothing contained herein shall be construed as prohibiting the City, its directors, officers, agents, or its employees, from defending through the selection and use of their own agents, attorneys and experts, any claims, actions or suits brought against them.

The Vendor shall likewise be liable for the cost, fees and expenses incurred in the City's or the Vendor's defense of any such claims, actions, or suits.

## **PAYMENT TERMS AND CONDITIONS:**

The City's payment terms are Net 30 days. The City is exempt from Missouri sales and use taxes and will not pay taxes for any product or service. A copy of the City's tax-exempt certificate shall be presented to the firm or company that is awarded a contract.

## SCOPE OF WORK / SERVICES

### **Goal and Objectives**

The City of O'Fallon is looking for a disaster and recovery solution capable of replicating and backing up all on-premises vSphere virtual environments (including VMs and virtual Networks) to a cloud object storage. This backup will be utilized for falling back and recovering any virtualized workload to on-premises environment. This will provide the city with offsite backups and a cloud-based disaster recovery site if needed. In the event of a disaster, this cloud-based backup snapshot will be utilized to recover all virtual workloads to a vendor managed cloud-based software defined data center (SDDC) and fall back all virtual workloads back to rebuild data centers. Solution needs to be fully managed where vendor will provide recovery services in the event of major disaster or disruption to a city wide operational network and resources.

### **General Requirements**

- Cloud based initial 3-year subscription to host 45 VMs (Fully vSphere Compatible especially when falling back – no conversion formats whatsoever)
- Annual billing over the course of the agreement is required
- Total Protected VM storage 50TB
- Cloud should be built-out as an On Demand Environment without Pilot-Lights. (Billed by actual usage once SDDC is constructed/operated until SDDC is destroyed)
- Billing for Cloud Storage Consumption (for Backup Snapshots) would be separated from On-Demand Environment Billing
- Minimum of two cloud hypervisor hosts in a redundant cloud geographic regions
- Datacenters must be based within the United States of America
- Cloud needs to be CJIS compliant
- Cloud provider will perform all necessary, virtual networking migration and replicate on-prem environment settings (so that virtual machines cloud IP allocations match the IP assignments on on-prem environment)
- Cloud provider will enable virtual firewall and assist with firewall rules for entry into cloud managed environment.
- Public IP addresses allocated for both firewall and Cloud entry points would be included and part of the solution (City will not be responsible for acquiring external public IP addresses for the managed Cloud). Minimum of 16 external public IPs will be reserved and consumed on demand, needed to support various external City services (e.g. GIS servers on public IPs and similar)
- Managed Cloud should also support some sort of build-in DNS & DHCP services (for private internal IP resolution) should internal DNS server become unavailable
- Managed Cloud Provider will also offer built-in, highly available NTP services for instances, typically accessed via simple hostnames to keep VMs and services synchronized, reducing dependency on external internet servers while ensuring accuracy and compliance within their ecosystems
- Virtual Firewall needs to have ability to support VPN Clients and Cloud Provider will assist with VPN Configurations for Client Machines connecting to Cloud Environment. Virtual firewall needs to support Ike2 and MFA authentication.
- Cloud provider will also help with third party firewall deployments (e.g. Watchguard FireBox)

- Total vCPU 178 GHz
- Total vRAM 1.5 TB
- RTO of 4 hours
- Ransomware Recovery for 40 VMs
- 60 Hours of Disaster Recovery test days should be included for City to test the ability to recover in the event of disaster. In addition, two Recovery Tests Yearly need to be performed by managed provider, who will also provide bi-yearly reports on Disaster Recovery Capabilities
- 5 Failover test days per year (Meaning that Provider will also demonstrate ability to failover to SDDC and back to on-prem environment). SDDC operation cost will be included in the price during these failover test days (where City will not be billed for SDDC consumption during times these failover tests are performed). These tests will be performed by Cloud Managed Provider with minimum of 7 (seven) test VMs (where provider will measure and report on times it took to perform failover on a test VM set, with an average of 250GB in VM size).
- Ability to use both Active Directory Native, as well as other forms of replications for both Virtual Environment and Windows Active Directory (e.g. Zerto, Veeam B&R or similar technologies for VM replications)
- 200 IOPS/TiB
- Steady state CPU headroom should equal 15%
- CPU utilization 30%
- Memory utilization 100%
- CPU overcommit factor 4
- Memory overcommit factor 1.25
- Average boot-up time of a VM after power-on begins should be no greater than 8 minutes
- De-dupe and compression ratio should meet or exceed industry standard
- Snapshots and retention should follow:
  - Every 4 hours and retained for 2 days
  - Daily at 12AM and retained for 7 days
  - Weekly on Sundays and retained for 3 weeks
  - Monthly on the 1<sup>st</sup> and retained for 6 months
- List cost for Egress per GB and Ingress per GB if any.
- List cost for professional services needed for deployment, initial setup and training.
- Creation of a Disaster Recovery Plan document that includes, but is not limited to a background to the City's DR capabilities, and a step by step direction of how to utilize SDDC and full restoration of data onto on-premise equipment
- SAML/MFA for access to system is required

### Evaluation Criteria

The City will conduct a fair evaluation process based on criteria listed herein and will use multiple criteria to select the most qualified vendor who represents an understanding of the City's needs.

The RFP will allow the City to review proposals and enter negotiations with the vendor whose proposal is most advantageous to the City with price and other factors considered. A number of factors will influence the decision in determining whether or not a vendor is qualified. The following list summarizes the major qualitative areas that will be evaluated, along with their overall weighting.
